So You Have a Palliative Care Advisory Council: What's Next?



As more states establish Palliative Care Advisory Councils, the **Center to Advance Palliative Care (CAPC)** has had an opportunity to speak with council representatives and learn about their efforts. Based on these discussions, we have compiled examples of activities that can help states expand access to palliative care:

Partner with key organizations

to combine and leverage available resources.



Example partner organizations include:

- → American Cancer Society Cancer Action Network (ACS CAN)
- → State Palliative Care Organizations and Associations
- → National Patient Advocate Foundation
- → Comprehensive Cancer Control Programs
- → Local **POLST programs**

Consider also reaching out to other local non-palliative care medical associations, as well as Medicaid Managed Care organizations, to discuss opportunities to pay for palliative care in your state.

Complete a capacity assessment

to inform decisionmakers where palliative care programs are and how many individuals current programs can serve, and help identify any significant geographic gaps.

Several states, including **Florida**, **California**, and **Colorado**, have completed capacity assessments and made their methodologies available for other states to replicate. CAPC is also working with states to build a comprehensive inventory of community palliative care programs through its **Mapping Community Palliative Care** project.

Codify definitions and standards

to provide legislators, patients and families, and providers with a shared understanding of what palliative care means in your state.

Example definitions and standards from

Colorado and Maryland can provide a helpful

starting point. It is also helpful to consult the **National Consensus Project's Clinical Guidelines for Quality Palliative Care** to help promote standardization across the field.



Build a centralized location

for information and resources about palliative care in your state.

Consider building a web page or similar resource that includes information on Advisory Council activities, background materials on



palliative care, leads on where to access palliative care locally (including **Get Palliative Care**), links to your capacity assessment and state association, and any other relevant information. **Connecticut**, **Massachusetts**, and **Alabama** have examples of Advisory Council web pages.
