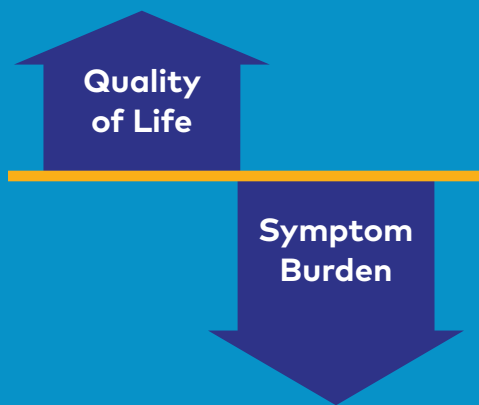


Palliative Care Ensures Value

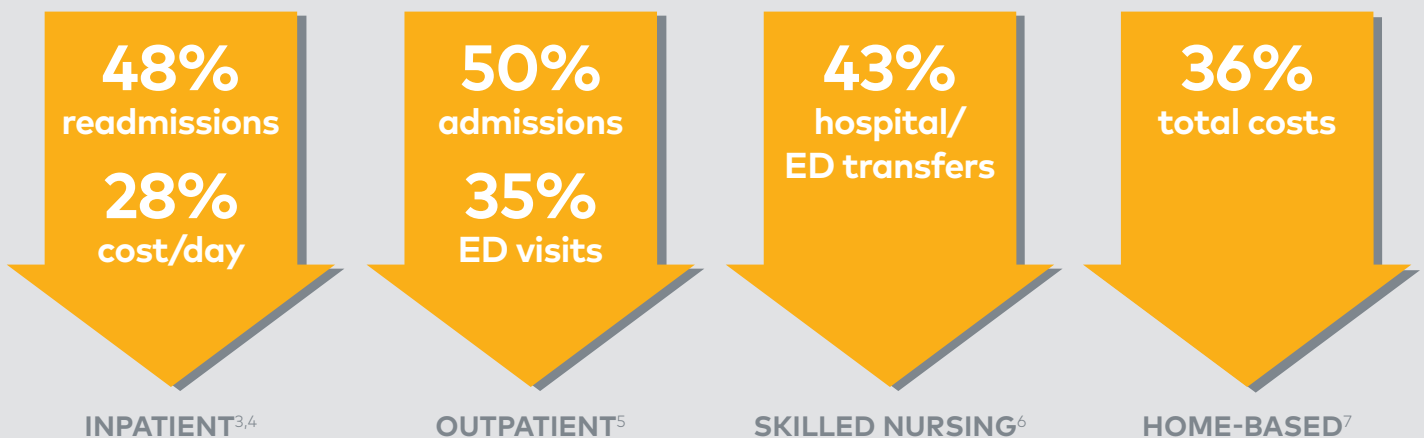
